Climate SMART Project Goals

- Blend public and private resources and support to catalyze conservation adoption at scale
- Empower the Truterra network of service providers to adapt their business models to include permanent conservation agronomy products and services
- Transform the way that CSC practices are adopted and the crops grown and sold
- Make an economic case for soil health that is backed by science
- Leverage knowledge and expertise from conservation professionals and the public sector
- Public funding as a scaffolding around the private sector while it builds a new, permanent business model for delivering conservation

Project Overview

- \$90,000,000 from NRCS
- 5-year project (Spring 2023 Spring 2028)
- 7.5 million acres of farmland impacted (corn, soy, wheat, cotton, dairy)
- 20,000 producers engaged
- Engage 7,000 historically underserved producers
- Hold regional trainings and develop mentorships
- Conduct soil health assessment and economic analysis
