

2025 Truterra[®] Early Adopter – a USDA-Supported Program (Region 2)

REWARDING ELIGIBLE EARLY ADOPTERS OF CONSERVATION AGRICULTURE PRACTICES

The Truterra[®] Early Adopter – a USDA-Supported Program will reward eligible farmers who made the transition to strip/no-till before crop year 2015. The program will include data collection and selected soil sampling, which will contribute to a publicly available soil health study by the Soil Health Institute.

FARMER INCENTIVE	\$25 per acre
ENROLLMENT PERIOD	Dec 11, 2024 – June 30, 2025, or until program enrollment cap is met
DUAL ENROLLMENT	Fields may be enrolled in this program plus the Truterra [®] carbon program or another commercially funded Truterra program. Fields must meet eligibility requirements for all programs enrolled.
FIELD ELIGIBILITY REQUIREMENTS	
GEOGRAPHIES	Select counties within AL, AR, MS, LA, GA, TN, KY, MO, and FL
CROPS	Corn (grain or silage), soybeans, cotton, wheat (grain or silage) must appear in the rotation three or more times between 2019 and 2025.
FARMER ENROLLMENT CAP	Maximum of 1,000 acres per farmer
PROGRAM ENROLLMENT CAP	Limited to 300,000 enrolled acres on a first-come, first-serve basis
FIELD PRACTICES	Strip/no-till must have been adopted before 2015 and must appear five or more times between 2019-2025. <i>Note: Reduced/conventional tillage years may not occur in consecutive years between 2019 and 2025</i>
FSA DOCUMENTS	<ul style="list-style-type: none"> 2025 subsidiary print showing that the CCC-902, AD-1026 (WELC/WC) and AD-2047 have been filed and that the farmer is not a foreign person. Certified field map with farm, tract, and field ID numbers
