2024 Truterra® Dairy Soils Carbon Programs

Create a new way to engage and reward pre-qualified dairy producers for sustainability practices generating reductions & removals on their row crop operations used for dairy feed. Open to both long-term & nearterm adopters; silage & alfalfa acres eligible.

<u>2025 Truterra® Financial Assistance</u> – <u>a USDA Supported Program</u>

Supports eligible farmers' conversion to strip/no-till and/or addition of cover crops in CY2025 by providing financial incentives on a maximum of 500 acres per farmer across one or more field boundaries.

2024 Truterra® Field Data Management Programs

Field data management programs aim to enable farmers within eligible geographies to participate in a sustainability program for eligible crop types.

2024 Truterra[®] Early Adopter – a USDA Supported Program

Rewards eligible farmers who made the transition to strip/no-till before crop year 2015. Includes soil sampling and data collection which will contribute to a publicly available soil health study conducted by the Soil Health Institute (SHI).
